#### January & February

- Team members review program's team webpage

- Set time to conduct a mapping exercise with members of the team that will be working on this improvement
  - Create a PDSA, find gaps in care, and determine a focus for intervention(s)

### April

- Revisit the team webpage to review materials as needed
- Review your PDSA and workflows to ensure all is running as intended, make adjustments if something isn't working
- Check in with other team contacts for best practice sharing as needed!

### May

- Check in on how the project is going and get ready to submit final outcomes data
- Submit the following by May 15, 2023
  - o Outcomes data form
  - o <u>Attestation form</u> (each physician requesting credit needs to submit)
  - <u>Program evaluation</u>; includes space to provide stipend information (one per team but any team member can provide feedback if interested)
- OAFP will provide each team a comparison of outcomes data for the project
- OAFP will provide a CME certificate for completion of the performance improvement activity
- OAFP will submit credit to the AAFP and ABFM for each family physician requesting credit (and that is eligible through those entities)
- OAFP will mail each team a \$500 stipend for participation in the program teams may use this as they wish!

Note: most national organizations will recognize credit for this activity as AAFP accredited activities are transferable. Encourage all members of the care team that participated in the activity to connect with their accrediting body to determine if they can also claim credits.
