Featured Alumni and Hosts - Covering 20 years

Dr. Eric Prenger (RHS 2002-2005) is a family physician in Sidney, Ohio and is affiliated with <u>Wilson Memorial Hospital</u>. He received his medical degree from The Ohio State University College of Medicine and has been in practice in the Sidney area since completing his residency.

Dr. Scott Rogers (RHS 2003-2006) is a family physician and recently appointed Associate Dean for Clinical Education, Ohio University Heritage College of Osteopathic Medicine, Reynoldsburg, OH. Following medical school at Ohio State and residency in Klamath Falls, OR, he has practiced in rural North Carolina and in urban Columbus, OH, where he served as faculty and Associate Program Director for the Grant Family Medicine Residency Program.

Dr. Lars Peterson (RHS 2004-2009) is a family physician who grew up in Utah, attended medical school at Case in Cleveland, OH, residency and early practice in South Carolina, and now practices in Lexington, KY, where he is VP for Research, American Board of Family Medicine.

Dr. Curt Mortenson (RHS 2006-2009) is a family physician who grew up in Kodiak, Alaska, before attending college and medical school in Ohio, before returning to Alaska for residency and now practice in Kodiak, AK, where he is medical director of the family medicine clinic there. (Invited)

He is also Director of Longitudinal Integrated Clerkships at the Heritage College of Osteopathic Medicine.

Dawn Mollica (RHS 2013-2021) is Administrative Director, Office of Rural and Underserved Programs, Ohio University Heritage College of Osteopathic Medicine, and Administrative Director, The RTT Collaborative, a nationwide non-profit cooperative of rural health professions education and training programs that promotes the development and supports the sustainability of education and training in rural communities.

Dr. Randy Longenecker, (RHS 2001-2021) a family physician in rural practice for 30 years in Logan County, Ohio, fifteen of those as Program Director for a rural training track residency program, is now a professor of family medicine and assistant dean for rural and underserved programs at Ohio University Heritage College of Osteopathic Medicine. He has created and directed more than a dozen programs in rural medical education and rural medical education research including the Rural Health Scholars program.

Rural Health Policy Institute and the NRHA Annual Meeting

Following the retreat, we will choose two students to attend the <u>Rural Health Policy Institute</u> in Washington DC, February 8-10, 2022, and two students to attend the <u>Rural Medical Educators</u> preconference and <u>NRHA Annual Meeting</u> in Albuquerque, NM, May 10-13, 2022. Those chosen will be notified by the end of November so they can make appropriate plans for being released from their medical school duties. The total travel and meeting stipend this year is \$750 per student and may be supplemented with other scholarships, including scholarships from the NRHA.
