Linda C. Stone, MD, MA, FAAFP

Dr. Stone is a wife, mother, grandmother, retired family physician, medical educator and retired Associate Dean for Student Affairs at the OSU College of Medicine. She currently serves as Special Assistant to the Dean for Humanism and Professionalism.

As a family physician, Dr. Stone served patients in Columbus, Ohio for over 25 years. She is past president of the Ohio Academy of Family Physicians (OAFP) and past chair of the OAFP Foundation. She has also served on the board for the American Academy of Family Physicians Foundation (AAFP-F) and as Chair of the AAFP Chapter Affairs Committee. She is a founding mother of the Elizabeth Blackwell Center for Women's Health at Riverside Methodist Hospital in Columbus and served as a Vice President of Ohio Health and Executive Vice President of the Medical Group of Ohio.

During her academic career with the Ohio State University College of Medicine she was the Predoctoral Education Director for the Department of Family Medicine creating the Family Medicine Leadership Development Program and the Family Medicine Honors program. Dr. Stone received the Arnold P. Gold Foundation's Leonard Tow Humanism in Medicine Award in 2003, was inducted into the Gold Humanism Honor Society in 2004, received the OSU College of Medicine Professor of the Year award in 2004 and was designated a Local Legend by the American Medical Women's Association in 2005. In 2005, she was named the Associate Dean for Student Affairs in the College of Medicine. She has received numerous teaching awards including the Lifetime Achievement Award from the OSU College of Medicine in 2009 and the Shining Star Award from the Office for Diversity and Inclusion in 2014. Michigan State University named her a Distinguished Alumni in 2010 and the MSU College of Communication Arts and Sciences named her an Outstanding Alumni in 2016.

The OSU College of Medicine's Chapter of the Gold Humanism Honor Society and the OSU College of Medicine created the Linda C. Stone Award in Mentoring in 2011 and presented the inaugural award to Dr. Stone. The Ohio State University Alumni Association honored Dr. Stone in 2014 with the Josephine Sitterle Failer Award for her continued work in humanism and professionalism. In November of 2016, the American Medical Association honored her work in the medical humanities with the Isaac Hayes, MD and the John Bell, MD Award for Leadership in Medical Ethics and Professionalism. In 2017, she was recognized by the Ohio Arts Council with a Governor's Award in the Arts.

Dr. Stone co-founded the Gold Humanism Honor Society Student Chapter at OSU in 2004 and the GHHS Resident Chapter in 2014. The student chapter was named the GHHS Outstanding Chapter in 2014 (the first year this national award was given). The resident chapter was honored with the GHHS New Chapter Award in 2016. In 2020, both of the OSU GHHS Chapters were given Exemplar Chapter designation.

In retirement, Dr. Stone chaired a group that founded the OSU College of Medicine Humanism in Medicine (HiM) program in 2009 including Medicine and the Arts Performing Arts Series; Humanism in Medicine Student Section (Professional School Orchestra, Ultrasound Choir, the HiM Writer's Group, Photography Group, Visual Arts group, Theatre/Film Arts and Dance in Medicine); the Courage to Teach faculty recognition program; the Humanism in Medicine Research Team; the OSU Collaborations in the Medical Humanities; MedArts Roundtable; and the HiM Philanthropic Board. In 2019, the dean of the Ohio State University College of Medicine, K. Craig Kent, MD, named the HiM program the Linda C. Stone, MD, Program for Humanism and the Arts in Medicine.

Retiring from the Humanism in Medicine program in 2020, she continues to serve the national Gold Humanism Honor Society, teaches the Advanced Competency in Professionalism and Humanism, is an invited lecturer locally and nationally, and finds joy in mentoring those in the humanism family. In April, 2020, she began her work with the *Voices in Humanism* collaboration with the Medical Heritage Center and the GHHS Resident Chapter at the OSU College of Medicine.
